

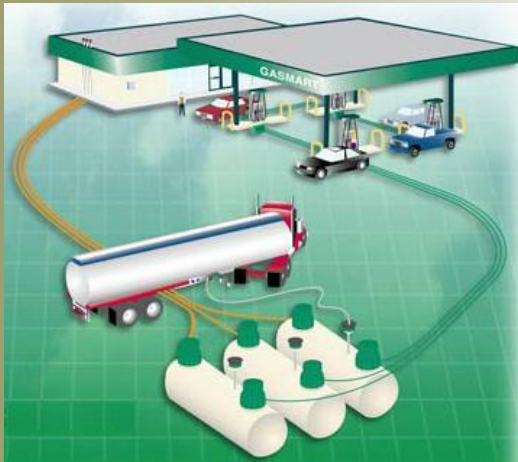

Class A & B UST Operator Training



Background on Training

The deadline to meet the EPA/Arizona-mandated underground storage tank (UST) operator training was August 9, 2012.

There are 3 classes of UST operators identified by the EPA:

- **Class A** Operator has primary responsibility to operate and maintain the underground storage tank system (i.e. owner/supervisor)
- **Class B** Operator implements applicable UST regulatory requirements and standards in the field (i.e. manager)
- **Class C** Operator is an employee and is, generally, the first line of response to events indicating emergency conditions (i.e. clerk).

All operators must maintain records (i.e. certificates) documenting that they received the appropriate training. This means that these records must be readily available for review if requested by the regulatory agency. Also, all operator training is valid for up to three years unless retraining is required earlier by ADEQ.

PMMIC will be tracking certifications in its database for the ADEQ.

What Does Training Involve?

The Arizona Petroleum Marketers Association (APMA) and Petroleum Marketers Management Insurance Company (PMMIC) have teamed up to bring the Class A & B UST Operator Training to you!

This training is a four hour classroom training that will be thorough yet easily understandable and relatable. The training includes a presentation, comprehensive review, examination, and certification.

This training provides the attendee with both a Class A and Class B certification and will also include specific training instructions for Class C operators, as they can be trained by an approved Class A or B operator.

Who Can Go?

This training is for operators who would like to be trained, retrained or have additional staff that needs to be trained as Class "A" and "B" operators.

This course is open to all who are interested. Membership with APMA is not required.

Multiple attendees from a facility may attend this course if seats are available.
