- Defeat of bill to raise the age of tobacco sales and possession to 21 (HB2335)
- Passage of reforms to the *Arizonans with Disabilities Act* (SBI406)
- Defeat of county option fuel tax bills (SBI446 and SBI147)
- Defeated:
  - Taxation of vapor products (SBI516)
  - Restrictions on vapor products (SBI517)
  - Taxation of sugar sweetened beverages (SBI443)
  - Raid UST Revolving Fund of \$30 Million

- Interim and 2018 Session Priorities
  1. Enact Diesel Tax Equalization
  2. Monitor Transportation Funding Discussions
  3. Prevent Raids to UST Fund
  4. Coordinate with Tobacco Industry on Sale Age Increase Proposals
